VI. **For Possible Action** – Update Regarding Interaction with the Governor's Office of Economic Development (GOED), Governor's Workforce Investment Board (GWIB) and General Overview of the Department of Employment, Training and Rehabilitation (DETR) Administrative and Sector Council Activities, Including Providing Direction to Sector Council Members Regarding Testimony during the Nevada Legislative Session..................................Frank Woodbeck, Director, DETR

Dr. Turner invited DETR Director Frank Woodbeck to provide the Council with any updates he may have. Director Woodbeck addressed the Council and:

- Asked the Council members if there were any questions regarding the policy direction given should they be asked by the Nevada Legislature to provide testimony during the session It was established previously that Council members can provide testimony in the legislature only in relationship to their occupational role and not their role as a member of this Council. There were no questions asked of Director Woodbeck in regards to this.
- Advised the Council that DETR is partnering with the Nevada System of Higher Education,
 Desert Research Institute and the Governor's Office of Economic Development to bring to
 Nevada an IBM Center of Excellence. He said that the IBM Center of Excellence will provide a
 very unique opportunity to access high-level data analytics tools that can be utilized for
 workforce development.
- Informed them that he had the opportunity to review their 2013 draft Strategic Plan and applauded the work that they are doing.
- Informed the Council that Senate Bill 52 has been pulled (Agenda Item VIII). This bill would have provided a loan program sponsored by the State to provide training in various sectors to individuals not eligible for some types of other training funding. The bill may be reintroduced at a future legislative session and DETR is exploring other funding sources, such as grants.

Dr. Turner thanked Director Woodbeck for his update and offered this Council's support if needed in collaborating with the IBM Center of Excellence.

X. **Discussion** – Update on the Health Workforce in Nevada Study......Dr. John Packham, Director Health Policy Research, University of Nevada School of Medicine

Dr. Packham explained that his report includes analysis of the supply and demand for the health care workforce in Nevada, what some of his findings are, some of the unique aspects of Nevada and how Nevada ranks in the nation. He provided a detailed discussion of these items, as well as how his report, although just recently completed, has been used to date. He plans to also conduct an additional study on vacancy and turnover supply, as well as developing demand models specific for Nevada and work on "developing workforce requirements." Dr. Packham also plans to write a white paper, which would be presented at a future Council meeting, on the forces that shape the health care industry workforce supply and demand in Nevada. A lengthy discussion amongst Council members and Dr. Packham ensued on Dr. Packham's report and various aspects of the health care and medical services industry as it relates to workforce development.

- - a. Workforce Connections Future of Nursing: Campaign for Action Dr. Debra Toney, Director of Nursing, Nevada Health Centers

Dr. Debra Toney reported on the National Summit for the Future of Nursing Campaign held in Washington, D.C. Along with Dr. Toney, Debra Collins and Linda Yi attended. She explained the key messages emphasized at the conference and she explained how these affect Nevada. She suggested that Council members track the status of SB69 and AB 170, and to look at a nursing workforce center. Dr. Turner invited Toney, Collins and Yi to give future updates and offered them the partnership of the Council to support such efforts. One member of this Council pointed out that this Council and the state of Nevada are headed in the right direction when it comes to nursing workforce development. Two other members pointed out that there is an area on the Nursing Board website that is specific to the actual nursing coalition. In addition, there should be future grant funding available to apply for between July and October 2013. They want to apply for those grant funds when they are announced.
