AGENDA

The Chair of this Council, Jim Barbee, called the meeting to order at 2:00 p.m. and welcome everyone. Mr. Barbee thanked everyone for attending this meeting and asked Derita Hopkins, Administrative Assistant for DETR's Workforce Solutions Unit, to call roll.

II. Roll call and Establishment of a Quorum Derita Hopkins, Administrative Assistant Workforce Solutions Unit, DETR

Ms. Hopkins called roll and informed the Chair that a quorum was not present.

Mr. Barbee asked Derita Hopkins to verify that the agenda for this meeting was posted according to current Nevada statute. Ms. Hopkins verified that the agenda for this meeting was posted according to NRS 241.020.

IV. **First Public Comment Session**Jim Barbee Members of the public will be invited to speak before; however, no action may be taken on a matter during public comment until the matter itself has been included on an agenda as an item for possible action. Public comment may be limited to three minutes per person at the discretion of the chairperson.

Mr. Barbee announced the First Public Comment Session; however, no comments were made. Hearing none, Mr. Barbee turned to Agenda Item V.

Mr. Barbee announced that this agenda item is being tabled to due to a lack of a quorum at today's meeting.

VI. For Possible Action – Development of the 2013 GWIB Agriculture Strategic Plan Jim Barbee

Mr. Barbee announced that he sent members a draft of the GWIB Agriculture Sector Council 2013-2014 Strategic Plan. Mr. Barbee announced that he would like to start by identifying critical careers and have growth potential through this Council's economic development and industry partners. He reviewed Objectives #1-8 as outlined in the draft and asked for any feedback.

Suggestions made during today's meeting were:

• Address industry workforce needs is to keep track of requests and data provided by agriculture industry companies as to the types of occupations they are currently hiring for and plan to hire for in the medium and long-term. Mr. Barbee informed the Council that he has access to U.S.D.A. statistics that may be of help, and De Salazar, Program Specialist for DETR's Workforce Solutions Unit, informed Mr. Barbee that data may also be given to this Council by DETR's Bureau of Research and Analysis, such as on job growth on certain aspects in the agriculture industry sector.

- Bring together representatives from K-12, higher education and industry leaders to provide information as a focus group. The Council decided that a focus group will be a part of Objective 3.
- Review other states' best practices for possibly applicability and implementation in Nevada for the workforce development initiatives of this Council.
- Determine employers' needs as developing higher education training curriculum.
- Develop an inventory of higher educational programs.
- Mr. McDowell announced that DETR is working on developing career pathways for youth in the agriculture industry. This information will be brought before the Council for their feedback.
- Identify what training goes with the critical careers, as well as if there are any training gaps they can identify. Mr. Barbee also agreed with this suggestion.
- Review funding sources, such as the K-12, community college and university funding streams.
 Council members and DETR WSU staff will seek to identify any other additional funding sources. DETR WSU staff or another appropriate recipient agency will pursue the funding opportunities. Partnerships will be built to facilitate the funding process.

Tessa Rognier, the representative on this Council from DETR's Bureau of Research and Analysis, said she has access to data on industry and industry occupations. She will review the available data and compile it for this Council.

The deadlines and tasks for each of the objectives were assigned as follows:

Objective #1: Frank Avera, Jeff Sutich, Rob Hooper, Jeff Brigger and De Salazar. Ongoing.

Objective #2: Initial data can be provided by DETR staff, with additional input by Frank Avera. Short term occupations to be determined by 01/01/14.

Objective #3: DETR staff will provide a youth career pathway for the agriculture industry based on information from the Nevada Department of Education and Nevada System of Higher Education. Additional initiatives will be developed after the youth career pathway information is completed. The information is desired by 12/01/13. Tracy Shane and Dr. Ron Pardini can provide information about their educational institutions' agriculture programs.

Objective #4: Frank Avera, Jeff Sutich, Jeff Brigger, De Salazar and Rob Hooper will review the data provided to the Council and provide initial recommendations for the Council to review. To be reviewed by 03/01/14.

Objective #5: All Council members. To be started after Objective #4 on 03/01/14 and completed by 05/01/14

Objective #6: All Council members and DETR staff. Ongoing.

Objective #7: All Council members, DETR staff and other potential partners. Ongoing.

Objective #8: Jim Barbee. On a quarterly basis at the GWIB meetings.

Mr. Barbee told Council members that he will update the draft with the information discussed at today's meeting and send out to Council members. He asked members to bring any additional feedback and recommended strategies to their next Council meeting.

Future agenda item(s) at this time will be the ratification of the 2013-2014 GWIB Agriculture Sector Council Strategic Plan. If completed, the youth CTE career pathways will be reviewed and a presentation scheduled for it. Tracy Shane (Great Basin College) and Dr. Ron Pardini (University of Nevada Reno) can provide information about their educational institutions' agriculture programs. Any presentations from non-degree certification programs available through the College of Southern Nevada and the Cooperative Extension at Western Nevada College are also desired.

VIII. Next scheduled meeting will be held on Tuesday, November 26, 2013 at 10:00 am..... Jim Barbee

Mr. Barbee announced that the next meeting is scheduled currently for Tuesday, November 26, 2013 at 10:00 a.m. Because of its close proximity to the date of Thanksgiving, alternative meeting dates will be reviewed. Council members will be notified and the agenda publically posted.

Mr. Barbee announced the Second Public Comment Session. Earl McDowell introduced Doug van Aman, a new Program Specialist with DETR's Workforce Solutions Unit. Hearing no other comments, Mr. Barbee turned to Agenda Item X.
