AGENDA

The Chair of the GWIB Health Care and Medical Services Sector Council, Dr. Marcia Turner, called the meeting to order at 8:30 a.m., welcomed everyone and thanked them for attending this meeting. She then

asked Ansara Martino, who was standing in for Derita Hopkins (Administrative Assistant for DETR's Workforce Solutions Unit), to call roll.

II. Roll call and Establishment of a Quorum Derita Hopkins, Administrative Assistant Workforce Solutions Unit, Department of Employment, Training and Rehabilitation (DETR)

Ansara Martino stated for the public record that she is standing in today for Derita Hopkins and called roll. She then informed Dr. Turner that a quorum was present.

Dr. Turner asked Ms. Martino to verify that the agenda for this meeting was posted according to Nevada statute. Ms. Martino verified that the agenda was posted according to NRS 241.020.

When Dr. Turner announced the First Public Comment Session, none were made. Hearing none, Dr. Turner turned to agenda item V.

V. For Possible Action – Approval of the August 8, 2013 Meeting Minutes Dr. Marcia Turner

Dr. Turner asked the Subcommittee Chairpersons if they had an opportunity to review the August 8, 2013 meeting minutes. A motion to approve the minutes was made by Dr. John Packham. It was seconded by Bill Welch. All were in favor. None were opposed. The motion carried.

VI. **For Possible Action** – Update on Sector Council Operational Activities Including an Overview of DETR's Sector Council Website...... Earl McDowell, Deputy Administrator Workforce Solutions Unit, DETR

Earl McDowell demonstrated DETR's new Workforce Solutions Unit website featuring information on the GWIB Industry Sector Councils. Mr. McDowell showed the Council their webpage, where their meeting information links could be found, and other pertinent information.

Dr. Turner began by reviewing the history of the GWIB Health Care and Medical Services Sector Council through current and the Council's completion of their 2013-2014 Layered Strategic Plan. The next step, Dr. Turner said, would be their deliverables due to DETR by December 16, 2013. These included: (1) the 2013-2014 Layered Strategic Plan; (2) their list of in-demand occupations as recommendations for how to spend Workforce Investment Act (WIA) funding; and (3) Pilot Program Recommendations. Dr. Turner reminded the Subcommittee Chairpersons of the data from the surveys and study that are still in progress and tasked Dr. John Packham with give some preliminary finds for the in-demand occupations.

Dr. Packham agreed and said that he will review also the data from DETR to provide any additional information that may arise and he gave a brief overview of the survey he will be conducting in January 2014. Dr. Packham stated that he will send them a draft of his survey and hopes they could provide him with feedback. He would also like to refer any possible policy recommendations to the Legislative/Regulation/Policy Subcommittee for consideration and he plans to reconduct the survey annually every January. Dr. Turner then opened the floor for discussion.

Mr. Welch discussed another survey being conducted by Council member Vance Farrow, Industry Specialist with the Governor's Office of Economic Development and Mr. Welch reviewed what his

subcommittee will be undertaking. Dr. Turner stated that both Mr. Farrow and Dr. Packham's surveys will be beneficial to the Council.

Dr. Packham informed the others that he would like an item on each of their Subcommittee agendas to review their Subcommittee's needs for data collection on a regular basis.

Next, Dr. Turner discussed her recommendation to change the name of the Economic Development Subcommittee. Suggestions such as "Industry Intelligence" Subcommittee arose. For Subcommittee meeting schedules, Dr. Turner stated that based on initiatives some subcommittees will meet monthly and others quarterly, and the Grants and Resources Subcommittee will meet on an ad hoc basis as needed.

Dr. Turner then turned to agenda item VIII.

Mr. Welch, Chair of the Economic Development Subcommittee, announced that his next Subcommittee meeting will be December 3, 2013 and he will review his Pilot Program recommendations, as well as his Subcommittee name change.

Dr. Turner asked Dr. Packham, Mr. Matheis and Ms. O'Mara if they had any additional comments. Hearing none, Dr. Turner turned to agenda item X.

Dr. Turner asked the Subcommittee Chairpersons to consider their recommendations for the Council's Pilot Program recommendations and to send them to Ansara Martino with DETR's Workforce Solutions Unit so she can compile them. Earl McDowell, Deputy Administrator for DETR's Workforce Solutions Unit, explained DETR's pilot project initiative and how funding has already been set aside for it. Mr. McDowell also elaborated on the Workforce Investment Act recommendations to be made by this Council and provided to the Governor's Workforce Investment Board. A discussion ensued amongst the Subcommittee Chairpersons and Dr. Turner. Upon conclusion, Dr. Turner turned to the next agenda item.
