AGENDA

Mr. Jim Barbee, Chair of the GWIB Agriculture Sector Council, called the meeting to order, welcomed everyone and asked for Ansara Martino, Grants and Policy Analyst with DETR's Workforce Solutions Unit, to call roll.

Ms. Martino called roll and informed the Chair that a quorum was not present. It was deficient by three members. Later during the meeting, members Irene Bustamante-Adams and Rob Hooper joined, leaving the quorum deficient by one member.

Ms. Martino confirmed that the agenda for today's meeting was posted according to NRS 241.020.

When Mr. Barbee announced the First Public Comment Session, Dr. Ron Pardini stated his name for the record and stated that the wanted to inform the Council that the University of Nevada, Reno has hired a new Assistant Professor, Antonio Faciola, for their Department of Agriculture, Nutrition and Veterinary Sciences.

Tracy Shane informed the Council that Heather Speal was present at today's meeting with Ms. Shane.

Hearing no other comments, Mr. Barbee turned the agenda item V.

Mr. Barbee invited Ms. Sue Poland, Education Programs Professional with the Nevada Department of Education Career and Technical Education (CTE) Programs office, to give an overview of the CTE programs offered in Nevadan school districts that are agriculture related.

Ms. Poland greeted the Council and using a PowerPoint presentation reviewed the Nevada Agriculture and Natural Resources Programs offered through CTE in 27 high schools throughout Nevada. She briefly described the following programs: Agriculture Business Systems, Agriculture Leadership, Communication and Policy, Agriculture Mechanical Engineering Technology, Veterinary Science, Ornamental Horticulture/Greenhouse Management and several other programs. Ms. Poland also spoke about the importance of integrating three key components to ensure the students' career success in

School-Based Agricultural Education (SBAE) and they were 1) contextual, inquiry-based instruction and learning through an interactive classroom and laboratory; 2) premier leadership, personal growth and career success through engagement in FFA, PAS, and NYFEA activities and programs; and 3) experiential, service and/or work-based learning through the implementation of a supervised agricultural experience program.

Mr. Barbee then turned to agenda item VIII.

Mr. Barbee introduced Dr. Frederick Steinmann, Extension Educator/Assistant Professor at University of Nevada, Reno, Division of Cooperative Extension. Mr. Steinmann gave an overview on how 4-H impacts economic development and Mr. Steinmann stated there are 49,000 young people engaged in 4-H programs across the state of Nevada. He continued by saying the 4-H programs promotes life skills development. The 4-H field staff are highly trained educators that deliver programs using appropriate and effective teaching methods. He also explained the 4-H Model which focuses on education and youth development, and how it impacts contextual influences. There are three foundations that are important in the 4-H teachings and they are learning, discovery and service.

Council members Irene Bustamante-Adams and Rob Hooper joined the meeting at this juncture.

One question of Dr. Steinmann asked about the enrollment numbers of youth in 4-H programs for Clark County? Dr. Steinmann replied that he would find out and forward the Council members the information as requested. Another question concerned land grant universities. Dr. Pardini replied that he would also provide the answer to that question to Council members.

It was requested by Mr. Barbee that Mr. Hays present information at the next upcoming Council meeting on how the agriculture industry compares with the other sectors. Mr. Hays agreed that he would.
