II. Verification of Posting

Odalys Carmona verified posting of the agenda per NRS 241.020 3(a)

Welcome and Introductions: None

Public Comment(s) Tracy Guinn opened the floor:

There were no public comments in Las Vegas, Reno or Winnemucca locations.

III. Review-Displaced Homemaker Program Grantee Reports/Facebook Ad Summary:

TMCC: Camille Vega stated that TMCC has not done any further Face Book postings. TMCC is working with individuals in the Justice System. TMCC has received GOED funding to assist individuals on parole and probation. Affected family members may be eligible for DH.

In reference to assisting Displaced Homemakers; TMCC has discovered that through the Division of Welfare and Support Services (DWSS) the state offers a 50/50 reimbursement for all funding spent for those in a SNAP approved training program. It must be funded by State funds only, which DH is. Normally if an individual receives SNAP and attends school SNAP can be taken away.

TMCC has closed "a ton of people" this final quarter from DH. Closing files due to a lot of turnover in the TMCC Re-Entry. A lot of files were of people not participating in the program. TMCC is a two year college so a lot of people coming in cannot go to school for two years with a family. In certificate programs TMCC works with Vocational Rehab and JobConnect Offices that have WIOA funds.

REVISION: Vocational Rehabilitation and JobConnect offices do not receive WIOA funds for training. Vocational Rehabilitation receives their grant money through the Office of Special Education and Rehabilitation Services Title V. JobConnect offices have Career Enhancement Program funds that are received from a percentage of the Unemployment Insurance taxes that are paid by businesses. WIOA is Title I funding.

With the GOED TMCC has 75 positions for individuals to get their manufacturing certificates completely paid for. The time frames for certificates are 3 months to almost a year. Many are self-paced. The manufacturing certificate could be a direct pathway to Tesla.

Tesla plans to hire 400 staff per month. They have started a shuttle to get to work. They have a recruiting office in Reno to hire direct. People that finish the Manufacturing Certificate start at a higher wage. The Governor promised to bring up the work force needed to staff Panasonic and Tesla. Camille is also working on training soon for the Getting Ahead Program and is familiar with Bridges Out of Poverty provided by the Food Bank.

Community Chest: Erik Schoen, presented

Regarding Facebook Community Chest felt that it was great exposure but in regarding Displaced Homemakers there was not a lot of recruitment.

06-1-18 Community Chest opened its 10,000 square foot integrated programing community center.

Staffing: there are two primary employment case managers. Their top DH person is also the lead Domestic Violence advocate and that is taking up most of her time. Erik has asked his Adult Case Manager Supervisor to take primary responsibility of DH and to share it with the team. Erik stated that it is hard to wrap your brain around DH and how exactly individuals qualify. He is hoping that this change will bring in more candidates as well as outreach to other rural counties.

Erik shared that his office has far exceeded the number of DH promised as a result of clearing up their process.

Frontier Community Action Agency (FCAA): Janine Robinson & Alaine Kliewer-Nye Presented

Janine wanted to let the group know that they have been working with Friends In Service Helping in Elko. Due to the lay out of the mining community individuals are shared between the two entities. The Great Basin Community College is also out of Elko for certificate programs. Janine also visited with Nevada Community Action Agency (NCAA) in Gardnerville. Janine went down to explain the DH Program so that they have the knowledge of the program.

Alaine stated that she went to a family custody meeting but the judge was not available to discuss the DH Program but she did speak with the "Ask A Lawyer" people.

Wendy at JOIN does want to work in a partnership with FCAA.

Next quarter they expect to have better numbers with exiters getting on their feet. Currently 5 have obtained jobs.

Louise Helton noted that FCAA needs to revise next quarterly reports to reflect # of participants entering employment and average hourly wage.

HELP of Southern Nevada: Denise Gee and Mallory Cyr presented Louise asked that the center review and correct their reports.

Denise Gee: Going through System changes. DOL WIOA dollars were reduced in Nevada due to the good/low UI rate.

WIOA Adult/Dislocated Worker –A Displaced Homemaker can be dual enrolled to provide certificate based training.

Drop Out Recovery

Continuing to branch out and look at new funding or local dollars. Due to low employment rate they are seeing a lot of barriers.

Moving from Gibson Library in Henderson to a new library near Bonanza and North Eastern slated for 2019.

Excited that there will be a seated staff member at the JobConnect on Maryland Parkway where they are looking at a 215 Program and targeting DH. HELP anticipates the participant numbers will grow again and they will try to help alleviate some of the many barriers faced by the Displaced Homemakers.

Mallory Cyr: Files are currently up to date with which clients are active and engaged with staff. In the challenge of doing clean-up of records a success story was found: Robin who had started her own company. Quarterly report reflects one client that started her own business and reflects exiting of clients enrolled in years past.

Corrective Action Plan has been completed and closed and are moving forward in a good direction. At the moment HELP is in the process of hiring an outreach specialist. This full-time position will be out in the community to reach out to targeted areas in Boulder and Pahrump to inquire about potential enrollment clients so that they can be directed into the HELP Office for assistance. New Outreach Specialist is Bi-lingual.

HELP is targeting larger employers such as Southwest Gas and MGM. Looking at the need for job shadowing for employers to get to know clients.

Louise Helton asked for HELP to revise the report for next quarter.

- 8. Discussion Nevada's Divorce Rates Last 7 YearsLouise Helton Odalys Carmona said that nowhere in Nevada is there an archive history by Nevada. Only information county by county. HELP does not have the funds as a Displaced Homemaker Program to provide employment and training it is just referrals out. Mallory feels that the script would be false advertising for HELP. They are connecting their client to their own skill set.

Second regarding the Face to Face and Best Practices within the agencies she hopes that a conversation can start to build a draft agenda for those few hours together on September 10th, 2018. Her hopes are that they can begin to engage as providers with agencies outside of the DH Board Meetings.

Public Comment: Reno Teena Park pointed out that the board members travel would be arranged by WISS staff. Members need to make their own hotel arrangements in order for air travel to be booked. If Sure Stay Hotel is used, across from the airport, when the board members arrive in the morning they will not be able to check in until 4 PM. It was also mentioned that ground travel will be needed to TMCC and Community Chest in Virginia City. It was clarified that Samantha Hill-Cruz will not be driving and TMCC was no longer at the meeting to confirm an available vehicle. Louise stated that there is plenty of time to set those things up for September.
