# 15. Truckee Meadows Community College (TMCC)

**Chad Venters** has 3-6 DH participants from past quarter. All of them have been receiving resume evaluations, job hunt analysis, and Microsoft office tutorial training where needed. One participant graduated out to a position, the second one went through a CNA program that was funded through Sandy Grant, and the third one graduated from college.

#### 16. HELP of Southern Nevada

Madelyn Oropeza is happy to report that HELP has enrolled 150 individuals into the DH program, and they have exceeded expectations in their goals to continue enrolling. From July of last year till now, 162 had enrolled, but have 150 participants as of right now. The good thing is that 83 participants from the program attained employment and 15 are enrolled into training. Because of the training, HELP was able

to get the employment piece of that with good income at \$20.00/hr. average pay which is good. Piggy backing on what Chad Venters had mentioned about Sandy Grant, HELP has joined forces with the Sandy Grant Project. Madelyn has recently finished training so she can collaborate with them so they can receive funding or vice versa. This is all in hopes to get individuals employed.

# 17. Community Chest

Erik Schoen mentioned Summer Programs are in full swim and as we know ECE capacity or summer space is in demand, and they are taking twice as many if they have slots.

Kallie Day This time of year they combine H&R WIOA programs that really work well for them. Community Chest is also running out of WIOA MONEY, which is a great problem to have. Contracts are ending at the end of this month. CC currently has kids in WEX and enrolled 18 new OSI adult ER clients but none of those are DH. CC is currently having a hard time enrolling anyone in DH which typically they don't. They think this is due to the lack of childcare, low UI rates, mental health needs and barriers. But really, they think that their clients don't understand the eligibility form. CC has been thinking a lot about this going into the next year as in how they are going to ask questions for future supplemental information. Kallie strongly believes that they do have DH clients who aren't identified on the eligibility form. Kallie would like to meet with Paulina Adrian and Samantha Hill-Cruz and get some feedback on the eligibility form. CC had a DH client that they hadn't served in a year. This DH client was in a training she did not complete due to CC helping her obtain employment at \$22.00-\$25.00/hr. A year went by, and the client completed her training, and her case manager is now helping her obtain employment. This was a fun and exciting experience for her case manager. This has helped CC build good relationships with clients.

Chair Helton asked if there was anything we would like to add to the agenda for the next meeting.

- TMCC Staff Chad Venters mentioned some confusion during the last quarter regarding the date
  the report needed to be submitted. Chad asked Samantha if she was going to send invites when
